Prerequisite: MUSI 4326 (Recording Techniques III). Must be a junior or senior and receive permission from instructor.

Description: This course gives further study and practical studio work for students who have successfully completed the required recording techniques sequence (MUSI 3394, 4390, 4325 and 4326) utilizing Studio 301 in an independent study format.

Assignment: See Final Project Assignment Sheet.

Attendance: Although this course is independent in nature, we will meet during the last week of classes to listen to your work together as a class. We will also meet twice throughout the semester as a class to discuss your progress and workshop any problems that you have (time TBD).

Attendance to these three meetings is mandatory. Each absence will result in a 5% drop in your overall grade for the semester.

Makeup Policy: Late assignments *are not* accepted. If you have extenuating circumstances you must talk to me before the due date and I must approve of a change *in writing*. ATTENDANCE:

At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator of student success. This date is reported to the Department of Education for federal financial aid recipients.

DROP POLICY: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. FINAL REVIEW WEEK: A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week unless specified in the class syllabus. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
