Purpose of the course: A brief review of thermodynamics, fundamental principles of statistical mechanics, Liouville theorem, entropy, Fermi-Dirac distribution, Bose-Einstein distribution, Einstein condensation, density matrix, quantum statistical mechanics, kinetic methods, and transport theory.

Content of the course: Selected topics from mainly the part B of the main textbook. The focus will be on the statistical mechanics.

Home Work: Homework will be assigned sporadically throughout the semester. Solutions will be discussed after the due dates, whenever necessary. Start working on the HW early. No late submission will be accepted. **Also, no make-up HW will be assigned for extra credit.**

Exams: There will be three exams:

1st Exam: Feb. 27, 2020

2nd Exam: April 07, 2020

3rd Exam: May 14, 2020

There will be no make-up exam.

Attendance: Attendance in the class is highly encouraged. However, if you missed class/classes it is your responsibility to know what/when the HWs are given or if there is any change of plan.

Grading policy:

Home work: 10% (some special HWs may have higher percentages, will be announced when assigned)

Each exam 30%. ($3 \times 30\% = 90\%$)

A: 90 and up; B: 75-89; C: 60-74; D: 50-59; F: 50 and below.

Note:

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students
